

Recommendation by authorized pension providers on reimbursement of vocational rehabilitation costs in 2023

The Acts on earnings-related pensions include provisions for the right to vocational rehabilitation. In line with this recommendation, rehabilitees are reimbursed for vocational rehabilitation costs incurred during work trials, study and job coaching. In addition, the service provider's costs arising from participation in the rehabilitee's rehabilitation assessment may be reimbursed.

The costs of rehabilitation are reimbursed in accordance with this recommendation. The payment of compensation is discretionary. The sections of the recommendation indicate the rehabilitation activities to which the guideline sections apply.

Pension providers support vocational rehabilitation through compensation that does not necessarily fully cover the real costs of rehabilitation.

Compensation must be sought in accordance with the instructions issued by the pension provider within six (6) months of the date when the costs are incurred.

The pension provider in charge of rehabilitation must be up-to-date on the rehabilitee's situation throughout the rehabilitation. Contact with the pension provider is very important when the rehabilitation plan is not progressing as planned.

Preconditions for reimbursement of costs

In order to receive rehabilitation benefits, the student must give the pension provider a certificate of attendance as well as a transcript or some other reliable certificate of the progress of studies each academic year, in accordance with the instructions issued by the pension provider. In the case of work trials, signed work trial agreements must be submitted to the pension provider.

Rehabilitees who are in a work trial or studying are reimbursed for the statutory essential requirements on the basis of separate deliberation (for example, a hygiene passport, a criminal record extract and a hepatitis vaccination).

If the studies or work trial are interrupted for a week or for a longer continuous period of time, the rehabilitee must notify the pension provider of this without delay. If notification of interruption is neglected without cause, the compensation paid may be recovered.

Studies in Finland and the consequent costs are reimbursed as vocational rehabilitation. However, if the rehabilitee completes a training programme abroad and the training is approved by an educational institution, the costs arising from the



rehabilitation are reimbursed as they would have been reimbursed in Finland. Travel costs between Finland and the training location, or per diem allowances, are not reimbursed.

Costs arising from studying (studies)

The standard compensation for studies supports the costs arising from the rehabilitee's studies leading to a degree. The standard compensation covers, among other things, the costs of textbooks and the necessary study aids and other study-related equipment, as well as the costs of excursions and trips included in the study programme.

The rehabilitee is not reimbursed for costs related to enrolment, such as preparatory courses, costs arising from entrance examinations, trips to the examination location, entrance examination books or, for example, medical statements or other investigations needed for enrolment.

Standard reimbursement for costs caused by studies

A standard reimbursement is used to compensate for studies taking at least one academic year/study year and leading to a vocational upper secondary qualification, vocational qualification, or academic degree at an educational institution, or vocational studies leading to a qualification.

The standard compensation is **EUR 600** per year. The compensation is paid in either one or two instalments according to the pension provider's instructions.

If the studies take less than six months but at least two months, we pay half of the standard compensation.

The normal compensation for parts of a qualification lasting less than a year is EUR 300.

However, the tuition fee for the right to study may be reimbursed on the basis of separate discretion.



Travel between home and the rehabilitation unit

In general, the rehabilitee is reimbursed for travel between the permanent home and the rehabilitation unit. Daily journeys between home and the rehabilitation unit are reimbursed if the distance is at least 10 kilometres.

Daily travel expenses are reimbursed to the rehabilitee monthly on the basis of the real number of study/work trial days that have taken place. The amount paid, based on round trips, is **EUR 0.13 per kilometre**. Work trips during the working day are not reimbursed.

Calculation formula:

Number of completed study/work trial days x round trip (km) x €0.13

Travel compensation is paid up to EUR 660 per month.

Compensation requires that the rehabilitee gives an account of the length of the trip. The pension provider checks the distances from publicly available route search services (e.g. Fonecta.fi or Google Maps).

If rehabilitees undergoing work trial, training or apprenticeship are paid a salary by their employer, travel expenses are not normally reimbursed. Travel costs are then normal tax-deductible expenses.

Compensation for housing costs outside home

Housing costs

If, in addition to the regular place of residence, the rehabilitee must acquire a second home in the rehabilitation location, incurring additional costs, the housing costs are reimbursed according to the lease and the relevant housing receipts. No compensation is paid if the educational institution has provided the student with free housing.

If the rehabilitee must find temporary accommodation in the rehabilitation location, the accommodation costs are reimbursed up to a maximum of **EUR 100** per 24 hours.

Housing/accommodation compensation is paid up to a maximum of EUR 660 per month.



Travel between home and the place of study

People staying at a temporary location because of studies are compensated for at most four **round trips** to their home location in a calendar month if the distance between the two locations is at least 70 kilometres. The compensation is **EUR 0.13** per kilometre.

Calculation formula:

Number of completed home trips x round trip (km) x €0.13

The compensation for home trips is at most EUR 330 per month.

Additional information requested by the pension provider or visits to rehabilitation service providers

If the pension provider specifically requests that an applicant for a disability pension or a rehabilitee goes for an examination or some other procedure, or consults a rehabilitation service provider, the pension provider compensates for the costs of the resulting medical report and/or other examinations.

Travel expenses are reimbursed according to public transport fares. If the use of public transport is not possible due to missing transport links or illness, the reimbursement is **EUR 0.13** per kilometre.

Any additional costs caused by the travel days are reimbursed by a per diem and an allowance for accommodation as follows:

- If the trip exceeds 6 hours, a partial per diem of EUR 22 is paid.
- If the trip has exceeds 10 hours, a full per diem of EUR 48 is paid.
- A per diem is paid only if the measures incur additional costs, for example in the form of meal costs.
- The allowance for accommodation is up to EUR 100 per 24 hours of travel.

Entry into force of the recommendation

This guide applies to costs incurred after 1 January 2023.
